## 1. Who are we?

www.FINBOURNE.com is a website (“**Site**”) of FINBOURNE Technology Limited (“**We**”, “**us**”, “**our**” or “**FINBOURNE**”). You can contact us on our [Contact Page](#)

If you are permitted to use FINBOURNE’s technology platform (our “**Platform**”) this Cookies Statement will apply to that Platform too, and reference to “Site or Platform” shall be as applicable to your use.

We use website tracking technologies (commonly known as “**Cookies**”). Cookies are data that are stored on your device when you use our Site or Platform and recalled as part of your continued use. Cookies can typically be set to expire shortly after they are needed, or retained on your device to help recognise you on future visits to our Site or Platform.

This Cookies Statement explains how we use Cookies. By using our Site and/or Platform you consent to receive the Cookies set out below.

## 2. Our use of Cookies

We use two different categories of Cookies as follows:

- “**Strictly Necessary Cookies**”

These Cookies are a required part of the operation of certain parts of our Site or Platform to recognise you as a continued user of our Site or Platform. If you disable or refuse these Cookies some parts of our Site or Platform may not operate correctly or at all. These Cookies are set to expire shortly after you last use our Site or Platform.

- **"Analytics Cookies"**

We and our service providers also use Cookies to track your visit, so that we can analyse how our Site or Platform is used. For this we use a number of third party services. Our service providers who set cookies include Amplitude, HubSpot and Google Analytics, as follows:

### **3. Google Analytics**

In order to provide website visitors with more choice on how data is collected by Google Analytics, Google has developed the Google Analytics Opt-out Browser Add-on. The add-on communicates with the Google Analytics code on our Site or Platform to stop data being sent to the Google Analytics servers. The Google Analytics Opt-out Browser Add-on applies to Google Analytics only and does not affect usage of our Site or Platform in
