Who are OMBA?

Founded in 2017, OMBA offers wealth, asset management, and advisory services for family offices, high-net-worth clients, and independent financial advisors. Specialising in exchange-traded funds (ETFs), OMBA builds and manages globally diverse, low-cost portfolios of ETFs, which are robustly managed through a transparent process to deliver value to investors.

What challenges did they face?

Data, data, data

OMBA knew that if they were going to scale, they needed to have a very firm grip on their data. Due to their unique multi-custodian operating model, OMBA receives hundreds of different data files from over a dozen different custodians every day. OMBA found that the quality and accuracy of data provided by their custodians varied dramatically. To ensure that their clients' positions were reflected accurately, OMBA needed to create a system that quickly and efficiently identified errors in the data they received to ensure accurate portfolio analysis, trading, and reporting.

This was no easy feat - OMBA found themselves having to grapple with large volumes of historic data. This work included the need to migrate 1.2 million positions and thousands of historic transactions across a wide range of ETFs and global markets. Tackling the scale of the data challenge would be impossible unless OMBA could realise an automated, scalable data platform that would provide a core system to power their portfolio and operations teams.

How did FINBOURNE help?

After evaluating multiple vendors, OMBA chose FINBOURNE to help them create their core data system. OMBA used FINBOURNE to:

OMBA also automated their pre- and post-trade compliance checks and performance calculation processes, further streamlining and optimising their operations.



Provide accurate integration feeds and reports:

OMBA used FINBOURNE's Luminesce data virtualisation engine to provide their client portal and reporting solutions with high-quality reconciled data. They maintained rigorous quality control to prevent inaccurate data being presented to clients, ensuring they maintained their trust and confidence.
